Bendigo Health

With more than 4,500 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Clinical Operations Division

The Clinical Operations Division encompasses acute and mental health services with a focus on excellent care, every person, every time. We provide a wide range of general medical, surgical and speciality services including oncology, cardiology, renal, emergency, women's and children's, critical care, specialist clinics and mental health services.

Within a state of the art hospital, the team provides high quality services using the latest technologies. Our eleven operating theatres (including 2 endoscopy rooms), critical care, emergency and women's wards all have access to critical services lifts that link to the helipad allowing rapid transfer of patients both in and out of the health service.

The Mental Health Service is a complex service that provides psychiatric care and treatment across a large catchment area in Victoria stretching from Swan Hill in the north of the state to Gisborne in the south. The Child and Adolescent Mental Health Service provides services to patients from birth to 17 years, the Youth Team covers ages 18 to 24 years, Adult Services cover patients from 25 to 64 years and the Older Person's Service manages those individuals over 65 years old.

Each year our onsite specialist clinics provide almost 95,000 occasions of service, we also see more than 52,000 people in our emergency department and welcome around 1400 babies into the world. The Clinical Operations Division assists with the admission of more than 49,000 patients into the hospital each year.

The Child and Adolescent Mental Health Team

CAMHS is a community based, multidisciplinary team that works with children and adolescents 0 - 18 years who are displaying serious emotional, relationship, personal care or behavioural disturbances that impact on family and social relationships and/or their functioning in home, school or the workplace.

While based out of JBC in Bendigo, CAMHS staff are also located at four regional locations across the Loddon-Campaspe, Southern Mallee region.

Services include:

- assessment and referral to acute inpatient, residential and non-residential rehabilitation, and other generic health services
- case management involving evidence based individual and family therapy
- crisis assessment and treatment
- assessment and treatment at the Loddon Child & Family Health and Wellbeing Local
- group parenting program at both CAMHS and the CFHWL.
- mental health education to carer and community groups
- mental health promotion
- consultation and liaison with other health workers and agencies, and outreach to smaller, more remote centres
- the Specialist Autism Assessment Service (SAAS)
- the CAMHS and Schools Early Action (CASEA) Program.

The Position

Team leaders and Senior Clinicians at Bendigo Health are an integral part of the health care service team, providing leadership and direction to a dedicated staffing group.

In the context of an integrated multidisciplinary community mental health team, and under the direction of the Manager and team Psychiatrist (s), the CAMHS Senior Clinician will provide support and leadership to their designated clinical teams. Providing clinical oversight to the intake, assessment and treatment, psychoeducation and support for patients and their families / carers. The Senior Clinicians within CAMHS may rotate through the various senior roles CAMHS offer.

Child and Adolescent Mental Health Services operates between 08:30am – 5pm Monday to Friday and is closed on Public Holidays.

Responsibilities and Accountabilities

Key Responsibilities

In a multi-disciplinary integrated community mental health team, and under the direction of the Manager and Consultant Psychiatrist(s):

- Provide bio-psycho-social assessment, deliver clinical treatment, case management and support to resolve or ameliorate psychiatric illness and emotional distress experienced by infants, children and adolescents, their families and carers, including some with more complex needs using a range of treatment modalities in both individual and group settings in the community.
- Provide strong leadership, support and clinical oversight and supervision to the team, mentorship and preceptorship of junior staff / students.
- Co-ordinate and provide intake services, providing single session / family consultation, assessment and clinical treatment, including crisis assessment, intensive treatment and support for young people, their families and carers.
- Manage a case load.
- In consultation with the Clinical Director/Consultant Child Psychiatrist, monitor the clinical practice of the multidisciplinary team to ensure the optimum standards of clinical care.
- Participate in Multi-disciplinary Team processes and provide sound discipline specific advice to other clinicians within the team.
- Continuously monitor quality standards across the region and recommend improvements.
- Engage and establish strong links with other key agencies and service providers (internal and external), and other relevant services.
- Participate in community consultation, awareness, education and develop community resources to increase the understanding of mental health issues around young people and families.
- Maintain a regional database of referral information and an allocation system of accepted clients and activity for CAMHS by way of a monthly report which identifies referral patterns, services needs and community request.
- Working with the CAMHS manager; contribute to the CAMHS Business Plan; participate in the recruitment, selection and induction of staff into the team; and coordinate annual leave requests of staff to ensure adequate regional coverage at all times.

- Maintain agreed statistical records.
- Deputise for CAMHS Manager as required.
- Depending on service requirements, work flexible hours, participate in on-call / re-call rosters, including weekends, as directed.
- Perform other duties as directed.

Generic Responsibilities

Code of Conduct - The Victorian Government's Code of Conduct is binding on all Bendigo Health staff. Infection Control - Every staff member has the responsibility to minimise incidents of infection/ cross infection of residents, staff, visitors and the general public. Confidentiality - All information concerning Bendigo Health, its patients, clients, residents and staff should remain strictly confidential. Any unauthorised disclosure of such information may result in disciplinary action.

Quality Improvement - Bendigo Health is dedicated to improving the quality and safety of health services by providing care within the following domains of quality: Consumer Participation, Clinical Effectiveness, Effective Workforce and Risk Management. As a result, we apply the concept of the quality cycle for all our quality activities, initiatives and projects thereby ensuring the best possible care and treatment results are achieved. The underlying principle of the cycle is that an activity is not complete until evaluation shows that it has been effective and reached the desired outcome. As a Bendigo Health employee you have a responsibility to participate in and commit to ongoing quality improvement activities using the framework of the NSQHSS (National Safety and Quality Health Service Standards).

Key Selection Criteria

Essential

- 1. Post graduate qualifications in mental health and/or related field.
- 2. Extensive experience and competence in the provision of community based clinical child and adolescent psychiatric services and an ability to assess and manage complex clinical issues in the context of multi disciplinary teams.
- 3. A comprehensive knowledge of the relevant legislation applicable to the provision of psychiatric services in Victoria along with a sound understanding of the requirements of service delivery within the context of Federal and State Government policies and strategic guidelines.
- 4. Demonstrated leadership, human resources management and interpersonal skills along with excellent written and verbal communication skills.
- 5. Demonstrated ability to lead a team and operate in an environment of change.
- 6. Demonstrated ability to liaise and consult with relevant family members, team members, a broad range of health professionals, and community agencies.
- 7. Knowledge of Quality Improvement and flexibility to operate and lead a team with a focus on continuous improvement.
- 8. Demonstrated evidence of participation in education and training of other staff, and an independent commitment to ongoing professional development.
- 9. Proficient computer and data entry skills.

Desirable

10. A positive, enthusiastic, passionate approach with high level communication skills, demonstrating the ability to develop effective working relationships, work successfully as part of a team and provide excellent customer service to both internal and external agency customers

Mandatory Requirements

National Police Record Check A current and satisfactory National Police Record Check must be completed by all new staff prior to commencement at Bendigo Health.

Immunisation As a health provider dedicated to providing quality patient care, we all need to be aware of the critical importance of infection control.
