### **Bendigo Health**

With more than 5,000 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

### **The Clinical Governance Division**

Clinical Governance is focused on upholding patient safety and a high quality of service through leadership, quality improvements, clinical performance, risk management, professionalism and excellent patient care. The division collaboratively provides high quality clinical governance support and advice, both internally and when supporting our regional Health Service Partners.

The Executive Director Medical Services (EDMS) oversees: GP Liaison, Medical Imaging incorporating BreastScreen, Pharmacy, Pathology and Research the Quality and Risk functions and Care of the Deceased.

The EDMS has responsibility for maintaining full compliance to accreditations and to deliver improvements through our response to the recommendations of both the national and Victoria's General Quality and Safety reviews. The Office of the EDMS oversees incident reporting, investigation of adverse patient events and complaints regarding clinicians. The EDMS provides leadership and support to the medical workforce to feel empowered to provide Excellent Care. Every Person. Every Time.

### The Medical Imaging Team

The Medical Imaging team performs a full range of diagnostic Imaging examinations to a consistently high standard using a patient focused approach. The team complete around 110,000 examinations per year and are responsible and are responsible for providing breast screen services to the Bendigo, Echuca and Mildura regions.

Imaging services are provided to inpatients of the Bendigo Hospital and to outpatients referred from Bendigo Health clinics and local GPs and specialists. The department is staffed by radiologists, medical imaging technologists, nurses and administration staff.

Medical Imaging services are available 24 hours a day, 365 days a year for urgent cases. Imaging services provided include:-

- General radiography (x-ray)
- Fluoroscopy
- Mammography
- DEXA
- MRI
- CT scanning
- Ultrasound (all general, obstetric, small parts, musculo-skeletal and vascular examinations)
- Digital Subtraction Angiography
- Intra-operative and interventional work
- Mobile x-ray and fluoroscopy

### The Position

The Night Shift Medical Imaging Technologist will perform General X-ray, CT, Theatre and Mobile x-ray to a consistently high standard using a patient focused approach for afterhours emergency department and hospital inpatients.

While holding a dedicated night shift position on the roster, they will be a valued member of the team, with requirement to rotate through day shifts quarterly to ensure that knowledge is shared and maintained. They will be a mentor to under graduate students and to other Imaging staff.

### **Responsibilities and Accountabilities**

#### **Key Responsibilities**

- Operate within the legal boundaries and Codes of Practice that govern the Imaging industry
- Ensure provision of a quality diagnostic imaging service overnight
- Be willing to work a minimum of 1 day per quarter in hours, to keep up to date with changes and training requirements
- Demonstrate a raised level of technical ability and skills in the production of the highest quality diagnostic images that are reasonably achievable given the patient condition and in accordance with the ALARA principles
- Ensure all examinations are performed efficiently with timing governed by clinical and patient need
- Ensure all examinations are presented for reporting with minimum delay and with accurate recording of associated details
- Provide constructive feedback to junior staff with regard to image technique quality and patient care.
- Recognise and report adverse events
- Collaborate with all multidisciplinary team members for the desired outcomes for patients
- Act as a mentor or preceptor to less experienced MIT's, including interns and students
- Conduct yourself in a manner that will not endanger yourself or others
- Contribute to safety awareness and promotion by contributing ideas and suggestions
- Report all radiation incidents immediately to the Radiation Safety Officer or Chief MIT.

#### **Generic Responsibilities**

**Code of Conduct** - The Victorian Government's Code of Conduct is binding on all Bendigo Health staff. ### **Key Selection Criteria**

#### Essential

- 1. Demonstrated high level experience and skills in general radiology, trauma radiology, theatre, CT, PACS/RIS
- 2. Knowledge of and experience in a Synapse PACS/Kestral RIS environment
- 3. CT scanner experience including IV cannulation competency
- 4. Knowledge of the CMBS and related imaging billing rules

6 AHPRA Registration as a Medical Radiation Practitioner a current Victorian Radiation Use Licence is mandatory.

#### Desirable

- 7. Ability to interact and communicate with a diverse range of people at all levels
- 8. A personal approach which is positive, enthusiastic, friendly and helpful
- 9. A willingness and ability to learn, work as part of a team, as well as to work independently
- 10. Flexibility to operate in an environment that requires constant prioritising of work and competing demands.

### **Mandatory Requirements**

**National Police Record Check** A current and satisfactory National Police Record Check must be completed by all new staff prior to commencement at Bendigo Health.

**Immunisation** As a health provider dedicated to providing quality patient care, we all need to be aware of the critical importance of infection control. Each staff member has a responsibility to comply with Bendigo Health's Staff Immunisation Policy and various infection control policy and procedures.
