## **Bendigo Health**

With more than 5,000 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 778-bed service that treats more than 57,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,700 new born babies in a year. In addition more than 17,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

# The Clinical Operations Division

The Clinical Operations Division encompasses acute, allied health, cancer and mental health services. We provide a wide range of general medical, surgical and specialty services including but not limited to; Oncology, Cardiology, Renal, Emergency, Women's and Children's, Critical Care, Specialist Clinics, Cancer Clinics and Mental Health Services. Our Allied Health teams provide a diverse range of programs and personcentred care in inpatient, outpatient, community, home and residential care settings.

Within a state-of-the-art hospital, our Ambulatory and Critical Care, Medical Services, Surgical Services and Women's and Children's areas use the latest technologies to provide excellent care. Our world class Cancer Centre uses a multi-disciplinary, integrated approach to treat specific cancers. The Cancer Centre offers medical oncology, radiation oncology, specialist nurses, clinical trials and cancer research, palliative care, and a Cancer Wellness Program.

The Mental Health Service provides psychiatric care and treatment across a large catchment area in Victoria stretching from Swan Hill in the north of the state to Gisborne in the south. Family sensitive practice is central to our models of mental health care and best practice ensures the identification, inclusion and support of families, carers and children.

Each year our onsite Specialist Clinics provide over 100,000 service events, we also see more than 65,000 people in our Emergency Department and welcome around 1700 babies into the world. The Clinical Operations Division assists with the admission of more than 57,000 patients into the hospital each year.

### The Surgical Services Department

The Surgical Services department is part of Bendigo Health's Medical Services Department and consists of two wards 5B and 6B.

The Surgical Unit specialises in a range of conditions related to surgery including the pre and post-operative care of patients. The specialties include minor and major abdominal; ear, nose and throat (ENT); head and neck; facio-maxillary; urology; reconstructive; and thoracic surgery. In addition, the Surgical Unit plays a pivotal role in patient flow throughout the organisation and Loddon Mallee region by facilitating transfers to and from the Emergency Department, ICU, Recovery, other departments and other health facilities.

The Complex Care room provides close monitoring and specialised care for patients with high clinical needs. Up to three patients can be admitted to this area, where a dedicated, experienced surgical nurse will care for them. This initiative has optimised the care the team are able to provide for acutely ill patients and has reduced the demand for high dependency beds in the Intensive Care Unit.

The Acute General Surgical Unit (AGSU) is an initiative to help streamline all general surgery emergency presentations. A dedicated team of both medical and nursing staff work within AGSU to expedite patients from the ED to theatre, or directly to the Surgical Unit as required.

The multi-skilled team of health care professionals of the Surgical Unit aim for the best patient outcomes and a smooth transition from hospital to home, through our close links with community services and other care providers. It is also committed to providing a positive learning environment for nursing, medical and allied health professionals.

### The Position

This position is one of a visiting consultant to Bendigo hospital, and aims to provide clinical care to outpatients at the Bendigo Hospital, and Paediatric Endoscopy services to selected Bendigo Health Paediatric patients with gastroenterological disorders.

The person appointed to this position will report to the Clinical Director of Surgical Services.

### **Responsibilities and Accountabilities**

#### **Clinical Care:**

- Provide clinical care for children with gastrointestinal, liver, and pancreatic disorders.
- Conduct thorough patient evaluations, including history taking, physical examinations, and ordering/interpreting diagnostic tests.
- Develop and implement individualized treatment plans, including medical, nutritional, and endoscopic interventions.
- Manage outpatients, including coordinating multi-disciplinary care.
- Attend and participate in relevant clinics

#### **Consultations:**

- Provide consultations to other medical staff and referring physicians regarding paediatric gastroenterology cases.
- Coordinate and follow up on inpatient and outpatient consultations.

#### **Endoscopy:**

- Perform and interpret endoscopic procedures, such as upper endoscopy and colonoscopy.
- Perform interventional gastroenterology procedures as appropriate.

#### Teaching:

Contribute to the education and training of medical students and residents.

#### Other Duties:

- Maintain accurate and timely documentation of patient care.
- Collaborate with other healthcare professionals, including nurses, dietitians, and social workers.
- Adhere to ethical guidelines and professional standards of practice.

## **Generic Responsibilities**

**Quality Improvement** - Bendigo Health is dedicated to improving the quality and safety of health services by providing care within the following domains of quality: Consumer Participation, Clinical Effectiveness, Effective Workforce and Risk Management. As a result, we apply the concept of the quality cycle for all our quality activities, initiatives and projects thereby ensuring the best possible care and treatment results are achieved. The underlying principle of the cycle is that an activity is not complete until evaluation shows that it has been effective and reached the desired outcome. As a Bendigo Health employee you have a responsibility to participate in and commit to ongoing quality improvement activities using the framework of the NSQHSS (National Safety and Quality Health Service Standards).

- Commitment to patient care and quality improvement.

- Familiarity with the referral patterns and demographics of the Loddon Mallee region.
- Ability to collaborate effectively with local healthcare providers
- Awareness of BH protocols or guidelines.

## **Mandatory Requirements**

**National Police Record Check** A current and satisfactory National Police Record Check must be completed by all new staff prior to commencement at Bendigo Health.

**Immunisation** As a health provider dedicated to providing quality patient care, we all need to be aware of the critical importance of infection control. Each staff member has a responsibility to comply with Bendigo Health's Staff Immunisation Policy and various infection control policy and procedures.
