Bendigo Health

With more than 5,000 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Community and Continuing Care Division

The Community and Continuing Care Division provides a broad range of high-quality, person-centred care programs and services to consumers in inpatient, outpatient, and community settings. Each service within the division is designed to ensure holistic care and improve the overall well-being of our patients and communities.

The Community Services team is dedicated to enhancing the health and wellbeing outcomes of the communities in the Loddon Mallee with six regional offices. This team includes: Aged Care Assessment undertaken on behalf of My Aged Care; Community Allied Health; Community Care; Carer Support and Community Nursing & Home Care.

The Continuing Care team delivers high-quality services across the Loddon Mallee region including: Dental Care; Chronic Disease Management; Outpatient Rehabilitation; Support for People Transitioning Home; Diabetes Management and Geriatric Management and Assessment.

The Allied Health team provides comprehensive, high-quality care across the continuum, including expert services in: audiology, dietetics, exercise physiology, occupational therapy, physiotherapy, podiatry, psychology, social work, speech pathology and allied health assistants who work with these disciplines.

The Geriatric Medicine Team includes Geriatricians, Rehabilitation physicians, Palliative care physicians, registrars and junior medial staff. The Team work across inpatients, outpatients and home settings.

In addition, the Community and Continuing Care Division holds the professional portfolio of Chief Allied Health Officer. The Chief Allied Health Officer and allied health discipline managers provide professional governance for all allied health across Bendigo Health.

The OPRS Stream D (Tissue Trauma/Hands)

The Outpatient Rehabilitation Services (OPRS) Team is located at the John Lindell Rehabilitation Unit (JLRU) on the Anne Caudle Centre campus and at the Stewart Cowen Community Rehabilitation Centre in Eaglehawk.

The Team provides specialist outpatient rehabilitation to children and adults in the Bendigo and Northern Victorian Region. Rehabilitation is time limited, goal orientated and aimed at maximising potential and quality of life and can be provided either in the centre or in the client's home.

Most clients receive a range of services including:

- Physiotherapy
- Occupational therapy
- Speech pathology
- Social work
- Nursing
- Medical
- Podiatry
- Psychology and neuropsychology

- Exercise physiology
- Dietetics

The Multidisciplinary OPRS Team is separated into streams focussing on Musculoskeletal, Neurological and Tissue Trauma. Services are offered within a rehabilitation framework and will provide client focused flexible rehabilitation for clients with complex rehabilitation needs.

The neurological steam team offer comprehensive assessments and management for clients with a broad range of neurological disorders who require rehabilitation. Some specialty services are offered within this stream and include spinal services and the Cognitive Dementia and Memory Service (CDAMS).

The musculoskeletal steam team offer assessment and management for clients with musculoskeletal disorders who require rehabilitation. Some speciality services are offered within this stream and include the back rehabilitation program and hand and upper limb rehabilitation.

The tissue trauma stream team offers a range of assessment and treatment for clients with wounds, burns, lymphoedema, diabetic foot complications and amputations.

The Position

The Grade Two Occupational Therapist/Physiotherapist is responsible for the provision of Occupational Therapy/Physiotherapy Services within a designated clinical caseload, appropriate to their level of experience and competency. Grade Two level Occupational Therapists/Physiotherapists are required to display autonomy of practice, whilst also contributing constructively to the interdisciplinary team.

The purpose of this position is to:

- provide best practice client centred clinical care to clients within the designated caseload in Outpatient Rehabilitation services of Bendigo Health
- This role sits primarily within the Hand clinic however there may be opportunities or a requirement for staff to work across other OPRS clinics, dependent on clinical skills and/or department need.
- OPRS operating hours are 8-5.30pm. Staff are required to work until 5.30pm one day/week.
- Contribute to the development of the Outpatient Rehabilitation service, as well as the general Physiotherapy department as appropriate.

Required Capabilities for Allied Health

Key Selection Criteria

- 3. Demonstrated understanding of contemporary practice and principles and evidence-based service delivery models for hand therapy
- 4. Demonstrated ability to work collaboratively with multidisciplinary teams to deliver safe consumer-focused care, providing specialist knowledge as required
- 5. Demonstrated ability to work autonomously with effective organisation and time management skills to actively plan and manage clinical and non-clinical priorities and meet timeframes
- 6. Demonstrated highly developed verbal and written communication skills with the ability to interact effectively with clients, carers, staff and the community
