

Healthy Food Systems **Framework Consultations**

Background

The Loddon-Mallee Public Health Unit (LMPHU) has been tasked by the Victorian Government with implementing population level initiatives to help keep people in our region healthy and well. Our priorities include climate change, mental wellbeing and healthy food systems.


The establishment and implementation of a healthy food system framework has been identified as a key priority in bringing stakeholders together to move our food system toward more sustainable circular economy in food production, social equity and increasing healthy eating. Adopting a system-wide view enables us to address the challenges at the population level that must be overcome to achieve this goal.

Healthy Loddon Campaspe (HLC) have undertaken a comprehensive consultation process across their catchment (Campaspe, City of Greater Bendigo, Mount Alexander, Macedon Ranges, Loddon Shires) and developed a healthy food system framework, The Flourish Framework. To reduce duplication, LMPHU has been been in discussions with Healthy Loddon Campaspe about upscaling The Framework across the Loddon Mallee region. It was agreed that the LMPHU Mallee and Murray teams would consult with their local stakeholders to review The Flourish and determine its applicability to the needs of their local food system (Figure 1).

Consultation Process

Stakeholders from Mildura, Swan Hill, Gannawarra and Buloke shires were invited to Healthy Food System Framework workshops via email and through the LMPHU update. A face-toface workshop was held in Mildura and on-line workshops for Swan Hill and Buloke/ Gannawarra stakeholders. Workshops were two hours long and included a HLC presentation on The Flourish Framework.

A follow-up survey was also offered to those that attended the workshops and those that were unable to attend, with a copy of The Flourish Framework.



Stakeholder Participation

The Table below lists the number of participants that attended the workshops in each LMPHU sub-region (n=30). There were 21 responses to the survey. Of these, 13 stakeholders had also attended the workshops and eight had not participated.


There was a cross-sector representation of local stakeholders (Figure 2) in the consultation. More work is required to engage with primary producers and food retailers. Full list of participants in Appendix 1.

Feedback results

The workshop participants expressed their enthusiasm for engaging in discussions about establishing healthy food systems. The prospect of developing a Healthy Food System Framework was met with anticipation, as it marked a significant step forward in their collective efforts. Acknowledging the importance of fostering healthy sustainable food systems for the well-being of both individuals and the economy, the participants recognised there is still much work to be done, particularly in addressing the limited access to locally grown food. The conversation was notably inspired by insights gained from discussions with the HLC, further confirming their commitment to advancing initiatives that promote healthy and sustainable food system.

Evaluation of the workshop can be found in the survey results (Appendix 2).

Is a Regional Food System Framework for the Loddon Mallee Region needed?

Workshop participants agreed that it is important to have a Healthy Food System Framework to focus and guide their work in this space. They were excited to see this being explored. It's an opportunity to bring stakeholders together in a partnership approach and provides an overview of the whole food system including primary production. This was confirmed in the survey, with all respondents (n=19) indicating a Framework was very/extremely important.

The Flourish Feedback

Workshop participants were very positive about The Flourish Framework and impressed with the level of process in its development. The survey indicated most agreed that The Flourish was important to their community, relevant and logical (see appendix for full survey results). Both the workshops and survey showed the majority of the respondents agreed (very/extremely relevant) with the objectives of The Flourish, however there were some concerns around the broadness of the objectives, language and implementation.

- Addresses a serious long-term intergenerational issue around poor eating choices and limited access to knowledge and good food.
- Love the idea behind it; long-term sustainable and holistic approach.
- Love the framework. Comprehensive and relevant. All objectives relevant.
- Like how it's a simple framework but the visual diagram makes it easy to understand.
- Good starting point, like the objectives and like the simplicity. Agree that the strategies are good.
- Love the opportunity that it's going to be a regional framework. This would enable networks to be stronger and more focused.

How can The Flourish Framework be improved for your area?

- Document needs to be more explicit around who the target audience is.
- A systems focus infographic illustrating local food systems (in addition to image on pg 6).
- Important to take into account that many people's individual values and bias' affect how we work in this space therefore more evidence examples needed.
- The Flourish Framework does not define what a regional food system is. The definition needs to be clear and measurable.
- Summary of key stakeholders would be of benefit who the stakeholders are and what their involvement might look like.

Objectives and strategies

- The objectives could be clearer and measurable. SMART objectives would be good.
- There are big objectives, some clarification or sub-objectives would be helpful .
- Identification of values and objectives in the flourish framework is great, but "Actions" need mentioning in a framework.
- Bit concerned with some of the strategies being more middle-class based not as appropriate for lower economic groups who might be more focused on getting food on the table, kids to school rather than the full breadth .

Language

- Language felt a bit high level for where we are at.
- Uncomfortable with the use of the word disadvantage. Needs specificity.
- Conscious about climate change language with farming/ag industry hot topic this needs to be moderated as modified practices.
- Concerns around the language what is a food policy?What does food policy really mean in the context? Is it advocate for food policy reforms - ? sugar tax?

Extending The Flourish Framework across the Loddon Mallee Region

Although stakeholders were very positive about The Flourish, there was a strong theme in the workshops and survey results that the development process is as important as the framework document. Stakeholders are keen to better understand their local context and develop a Healthy Food System Framework together.

- Flourish is a good example; this is not relevant to our community. The local stakeholders/community need to be involved from the start and built to represent our local needs.
 - Framework relevant to us but consultation and co-design happened down south great for people involved. Need to go on a journey with the local community to engage more people like primary producers and other stakeholders on the journey with us.
 - Flourish is great but was developed for HLC, we need to do further work to determine the objectives and inform the framework.
 - The objectives need to be thought through to determine if they are appropriate for our region evidence base.
 - It is a great framework however as discussed during the consultation it would be great to have a framework that meets the unique needs of the smaller communities like Buloke.
 - Very high level. Would be helpful to develop a framework for each particular region based on region issues. And include specific examples of what each strategy may look like for that region.

Additional focus areas in the Framework

The feedback generally agreed with The Flourish objectives but would also like to see a focus on:

- Local context, evidence and a mapping of the existing Food System
- Climate change lens:
 - Management of food waste
 - Reduce food miles
- Food insecurity and access, including disaster food relief
- Food literacy
- Build capacity to grow food

Next steps

After discussions with Healthy Loddon Campaspe, LMPHU next steps include:

- **The LMPHU Murray team** will engage local stakeholders/sectors in the Gannawarra, Buloke and Swan Hill shires; understand their local context and map their food system. Once this process is near completion, key priority objectives will be determined for each local government area (LGA). Following this we will also re-visit alignment to the HLC Flourish framework to assess if the key drivers marry with the Flourish objectives.
- **The LMPHU Mallee team** will lead a project with the broad aim of establishing a Mallee Food Strategy, incorporating Mildura Rural City LGA as well as Robinvale and Sea Lake communities. The project will first seek to establish governance with key stakeholders from across the food system represented, followed by scoping, research, consultation and co-design of strategies and implementation plans.
- The LMPHU Loddon team will continue to support the HLC in the implementation of the Flourish framework across the Loddon catchment (City of Greater Bendigo, Loddon, Macedon Ranges and Mount Alexander Shires). We will also work with local stakeholders/sectors to meet the objectives of the Loddon Mallee Population Health Plan which has additional objectives particularly pertaining to food security.



Q1 The following map outlines the 3 Loddon Mallee sub-region catchment areas








Q5 Please let us know how important you feel it is to have a Regional Food System Framework developed for the Loddon Mallee?





Q6 How relevant do you feel the objectives of the Flourish Food System Framework are to your work and/or community? (Please provide one response for each objective below)




Q7 Do you have any suggested changes to these objectives?






