Bendigo Health

With more than 4,500 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Innovation & Digital Services Division

The Innovation and Digital Services Division is charged with delivering technology solutions that deliver on our vision. As well as responsibility for the mainstream ICT services and support the division encompasses Research and Development, Innovation, ePR project, Project Management Office, Clinical Analytics and associated resources including the Chief Clinical Information Officers.

The Division leverages ICT technologies and expertise to provide the technical foundations for innovation and transformation of our clinical service delivery. Critical to this is the successful implementation of an ePR in the acute setting and the development of innovative ways to use the data this will create. The Division is instrumental in building a strong culture of utilising health informatics and using data to drive innovation.

The Architecture and Applications Team

The Architecture and Applications team manage the implementation, consolidation, integration and development of corporate and clinical information systems at Bendigo Health. The team is responsible for the development, maintenance and availability of applications within Bendigo Health. The team is split into three functional areas. Two areas focus on delivery of services and products (applications) to their users. The third, focuses on the overall effective management of the BHCG portfolio of applications (software), understanding what we have, why and for whom.

Loddon Mallee Shared Services

The Loddon Mallee Shared Services (LMSS) model provides for a single Regional Chief Information Officer who oversees delivery of the core and non-core services to all members of the Loddon Mallee Rural Health Alliance (LMRHA). The services delivered by the LMSS enable a supported delivery of core services to all Agencies within the region, and access to non-core services as required, whilst leveraging its position to engage services to support all Agencies.

The Position

The purpose of the Integration Specialist is to lead the planning, coordination, and solution development and implementation activities that enable the interaction of data between systems at Bendigo Health. The integration space within Bendigo Health is built on the Health Level 7 (HL7) messaging framework, which is coupled with our Integration Engine and HL7 archive database. Compliance not being mandatory coupled with varying levels of versions of HL7 implemented; integration within the Health environment also requires extra industry practices of Database Federation, ETL processes and API/Service employment. This role then is both complex and exciting requiring well developed analysis, design, database and programming skills. It is essential this role manages integration to the standards set by the organisation. Proven communication skills, problem-solving skills, proficiency in programming languages and data structures, and knowledge of integration best practices are critical in successful performance in this role.

Responsibilities and Accountabilities

Key Responsibilities

- Attend project and planning meetings related to the introduction of new systems and data streams where you will assess, recommend and implement an integration strategy.
- Monitor and maintain all development, test and production integration engines and processes including but not limited to; Microsoft BizTalk (current-state Bendigo Health integration engine), HL7 database archive and data warehouse/s.
- Provide integration support, development and recommendations to Bendigo Health projects.
- Liaison between infrastructure, applications and third party vendor groups where directed to achieve optimal integration solutions.
- Create and maintain system context diagrams and documentation for integration solutions in line with any changes to those solutions.
- Design, implement and maintain monitoring components within key points of the systems to ensure the integrations are working and that escalation occurs if they are not.

Generic Responsibilities

Key Selection Criteria

Essential

- 2. Ability to lead integration deliverables within large projects
- 3. A detailed knowledge of Integration best practice principles, Integration engines and development life-cycles.
- 4. A detailed knowledge of different messaging formats and integration protocols including but not limited to: HL7 2.x, CDA, XML, EDI, RESTful Web Services, FHIR and DICOM

Desirable

- 5. Experience in creating and updating Integration interfaces to meet specifications/business requirements.
- 6. Experience in requirement gathering, specification writing and preparing documentation for recommendations.
