Bendigo Health

With more than 4,500 staff and volunteers and covering an area a quarter of the size of Victoria, Bendigo Health, is an expanding regional health service offering the advantages of city life combined with the beauty and freedom that comes from living in a regional area.

Bendigo Health is a 700 bed service that treats more than 45,000 inpatients, triages more than 65,000 emergency attendees and welcomes more than 1,600 new born babies in a year. In addition, more than 15,000 operations are performed in our operating theatres and more than 100,000 occasions of services are provided in our clinics to outpatients.

The organisation provides services in emergency, maternity, women's health, medical imaging, pathology, rehabilitation, community services, residential aged care, psychiatric care, community dental, hospice/palliative care, cardiology, cancer services and renal dialysis to the people of the Loddon Mallee region.

With our main campus based in Bendigo, our services extend throughout the Loddon Mallee with sites in areas such as Mildura, Echuca, Swan Hill, Kyneton and Castlemaine.

Demand on services is increasing rapidly with Bendigo being one of Victoria's fastest growing regional cities.

The Clinical Operations Division

The Clinical Operations Division encompasses acute, allied health, cancer and mental health services. We provide a wide range of general medical, surgical and specialty services including but not limited to; Oncology, Cardiology, Renal, Emergency, Women's and Children's, Critical Care, Specialist Clinics, Cancer Clinics and Mental Health Services. Our Allied Health teams provide a diverse range of programs and person-centred care in inpatient, outpatient, community, home and residential care settings.

The Allied Health and Continuing Care Directorate offers a diverse range of programs and services which provide high quality, person centred care to clients and consumers in inpatient, outpatient, and community settings.

Our services include:

- Allied Health
- Community and Ambulatory Care
- Community Dental Services
- Referral Centre
- Rehabilitation, Geriatric and Palliative Medicine

The Allied Health team at Bendigo Health comprises over 400 staff including Audiology, Dietetics, Exercise Physiology, Occupational Therapy, Physiotherapy, Podiatry, Psychology/Neuropsychology, Social Work, Speech Pathology, Spiritual Care and Allied Health Assistance. Allied Health clinicians work in a very broad range of roles and are valued in the contribution they make to the multi-disciplinary team.

The Speech Pathology and Audiology Department

Speech Pathologists assess and manage feeding and swallowing issues in adults and children. As experts in communication, our team also provides professional diagnostic and therapy services to people with speech, language and voice issues.

COMMUNICATION

For Adults - the ability to communicate successfully is the key to social independence, inclusion and connectedness. Speech Pathologists are an integral part of the team supporting people following stroke, head injury, and progressive neurological diseases as well as other conditions that affect the ability to communicate. Communication assessment and management, including training for families and friends (communication partners) can be provided by the BH speech pathology team.

For Children - language development and the ability to communicate with others is a critical skill for life. Language is a pre-cursor to literacy development. Our team assesses and manages language development for children 0-6 years (prior to school entry). As well as comprehension and expression, issues with voice and fluency (stuttering) can be managed by our team.

SWALLOWING

Paediatric and adult dysphagia management is a specialist service offered by our team. Person-centred assessment, management and education for swallowing and oral nutrition as well as support for alternative and modified feeding options is offered by both our inpatient teams and specialist outpatient swallowing disorders clinic. Videofluoroscopy assessment of swallowing is arranged if required.

Speech pathologists can be found in almost all areas of Bendigo Health - on the Bendigo Hospital campus, Anne Caudle Centre campus and in local and regional teams servicing the Loddon Mallee region.

The Position

The Grade Three Speech Pathologist is responsible for the provision of Speech Pathology Services within a designated clinical caseload, appropriate to their level of experience and competency. Grade Three level Speech Pathologists are required to display autonomy of practice, whilst also contributing constructively to the interdisciplinary team.

The purpose of this position is to:

- Provide best practice, client centred clinical care to clients within the Paediatric Community Health Outpatient Services caseload, of Bendigo Health
- Provide teaching, supervision, support and development of less experienced staff and under graduate students
- Contribute to the development of inpatient Speech Pathology services, as well as the general Speech Pathology department as appropriate.

Responsibilities and Accountabilities

Key Responsibilities

The key responsibilities and duties of the Grade 3 Speech Pathologist include, but are not limited to:

Required Capabilities for Allied Health

Further to the key responsibilities outlined in this position description, Allied Health staff are required to demonstrate the capabilities outlined in the Bendigo Health Allied Health Grade Level Capabilities.

Generic Responsibilities

Code of Conduct - The Victorian Government's Code of Conduct is binding on all Bendigo Health staff. Contravention of a provision in the code may constitute misconduct and/ or regarded as a breach of the employee's employment agreement and will be dealt with under the organisations Counselling and Disciplinary Action Policy.

Compliance with policies and procedures - All Bendigo Health's policies and procedures are set out in its clinical and managerial policy manuals located on the intranet under PROMPT and in hard copy. All staff must ensure they comply with policies, procedures and standard ways of work practices when carrying out their work. Any breach in compliance may result in disciplinary action.

Occupational Health and Safety - Every staff member has the responsibility to take reasonable care of their own health and safety and the safety of others, to cooperate with Bendigo Health's OH&S policies and to participate in appropriate safety education and evaluation activities. All staff are expected to participate in reporting any health, safety and wellbeing issues. Any breach in compliance may result in disciplinary action.

Infection Control - Every staff member has the responsibility to minimise incidents of infection/ cross infection of residents, staff, visitors and the general public. All staff must adhere to the policies and procedures as set out in Bendigo Health's infection control manuals. Any breach in compliance may result in disciplinary action.

Confidentiality - All information concerning Bendigo Health, its patients, clients, residents and staff should remain strictly confidential. Any unauthorised disclosure of such information may result in disciplinary action.

Quality Improvement - Bendigo Health is dedicated to improving the quality and safety of health services by providing care within the following domains of quality: Consumer Participation, Clinical Effectiveness, Effective Workforce and Risk Management. As a result, we apply the concept of the quality cycle for all our quality activities, initiatives and projects thereby ensuring the best possible care and treatment results are achieved. The underlying principle of the cycle is that an activity is not complete until evaluation shows that it has been effective and reached the desired outcome. As a Bendigo Health employee, you have a responsibility to participate in and commit to ongoing quality improvement activities using the framework of the NSQHSS (National Safety and Quality Health Service Standards).

Key Selection Criteria

Essential

- A degree in Speech Pathology or equivalent tertiary qualification with the ability to satisfy the requirements of the Bendigo Health Allied Health Credentialing and Professional Standards document, including evidence of eligibility for membership of Speech Pathology Australia
- 2. At least 7 years' experience relevant to discipline in an inpatient setting
- 3. Demonstrated high level understanding of contemporary practice and principles and evidence based service delivery models for the relevant work area.
- 4. Demonstrated ability to work collaboratively with multidisciplinary teams to deliver safe consumer-focused care, providing high levels of specialist knowledge
- 5. Demonstrated ability to work autonomously with highly developed skills in organisation, time management, planning and priority setting
- 6. Demonstrated highly developed verbal and written communication skills with the ability to interact effectively with patients, carers, staff and the community

Desirable

- 7. Demonstrated leadership in innovative approaches to problem solving for individual consumers and/or service delivery, using highly specialised clinical skills or knowledge
- 8. Demonstrated commitment to continuous service improvement and demonstrated experience in the leadership, evaluation and implementation of quality improvement or research activities
- 9. Demonstrated experience in initiating, responding and contributing to change and leading others through this process
- 10. Demonstrated experience to lead and deliver the professional development and education of others in highly specialised clinical skill and knowledge areas

Mandatory Requirements

National Police Record Check A current and satisfactory National Police Record Check must be completed by all new staff prior to commencement at Bendigo Health.

Immunisation As a health provider dedicated to providing quality client care, we all need to be aware of the critical importance of infection control. Each staff member has a responsibility to comply with Bendigo Health's Staff Immunisation Policy and various infection control policy and procedures.
